2.2 Ownership

Dyno Nobel Limited (formerly Incitec Pivot Limited) is a public company, listed on the Australian Stock Exchange. The company was originally formed in 2003 through the merger of Pivot Limited and Incitec Fertilisers, is a history tracing back to the early 20th century. It expanded significantly in 2006 with the acquisition of Southern Cross Fertilisers Pty Ltd and its exit from the Orica group. In June 2008, the business broadened its global footprint with the integration of Dyno Nobel, further strengthening its position in the industrial explosives market.

The company was admitted to the S&P / ASX 50 index in September 2008. On 31 March 2025, Incitec Pivot Limited officially changed its name to Dyno Nobel Limited.

2.3 Product Range

- (a) Dyno Nobel Limited operates two distinct businesses: Incitec Pivot Fertilisers, a fertiliser manufacturer and importer with operations across Australia, and Dyno

Nobel, a global manufacturer and supplier of commercial explosives and blasting services.

4.5.2 Ownership

Incitec Fertilisers Operations Pty Ltd has acquired majority stake in Australian Bio Fert Pty Ltd (ABF). Founded in July 2015, Australian Bio Fert Pty Ltd was formed by technical experts from across the engineering and agriculture industries who sought to solve the problem of increasingly costly waste management and growing demand from farmers for crop nutrition products that lower input costs, increase yields and benefit soil health.

With private investment and support from the Victorian poultry industry, Federal and State government grants and the R&D Tax Incentive Scheme, ABF developed a pilot plant, product development and research facility near Maddingley in Victoria in 2018, where it now produces a series of biological fertiliser formulations to meet growing demand from farmers who recognise the benefits of increasing the plant availability of organic based nutrient, carbon content in soil and restoring soil health.

4.5.3 ABF Product Range

- (a) Australian Bio Fert (ABF) has developed a series of biological fertiliser formulations to meet this growing demand. Successful independent trials have confirmed ABF will deliver similar nutrient levels to plants as more traditional chemical fertilisers, whilst improving soil structure to enable more sustainable farming practises.
